

HELPING YOUR CHILD AFTER A CRIME

Information for parents and carers

If you or your child has been affected by crime, it can be a very frightening and traumatic experience.

We are here to help you and your family at this difficult time. We support hundreds of people of all ages every day to cope with the impact and effects of crime.

How crime may affect your child

Every child reacts to crime differently. You may notice a difference in their behaviour, sleeping or eating patterns may change, their anxiety levels may increase, and you my notice a lack of motivation to engage in school and leisure activities.

How we can help your child

VS is an independent charity, and your child does not have to report the crime to the police to get support from us.

We help children who have experienced all types of crime, including:

- Bullying and harassment
- Domestic abuse
- Online harm
- Sexual abuse and exploitation
- Burglary
- Hate crime
- Gangs and street violence.

Local services

At VS, we have a large number of local services providing specialist support to children across England and Wales.

These services provide high-quality support, designed to identify and reduce **risks**, recognise and build on **strengths**, and help young people increase their levels of **resilience**.

Our specialist support can be delivered both in person and through the use of technology. Our support may include one-to-one support sessions, access to group work programmes and peer support opportunities.

Indirect services

Some of our services provide indirect support to children. These services provide high quality specialist support to children through a safe parent/carer or trusted adult. We engage on a regular basis with the trusted adult, and provide them with a range of activities to complete with their child to help them cope and move forward from the harm caused.

Our support for children is confidential, which means that information will not be shared outside of VS unless we are worried that your child may be unsafe or at risk of serious harm. When we need to share information, we will always try to explain clearly what information we need to share. who we need to share it with, and what may happen next.
